

# **PRODUCT AND MANUFACTURER**

### ABOUT THE MANUFACTURER

### **PRODUCT DESCRIPTION**

This EPD is representative and relevant for the following EQUITONE range: EQUITONE [natura] 8 mm, EQUITONE [natura] PRO 8 mm, EQUITONE [textura] 8 mm and EQUITONE [pictura] 8 mm produced with grey cement. For those produced with white cement a separate EPD was created. All these EQUITONE panels are through-coloured large-size fibre cement facade materials.

The results declared in this EPD are for EQUITONE [natura] 8 mm using the anthracite base panel, which was chosen as representative product for the covered group. The representativeness of the EQUITONE [natura] 8 mm using the anthracite base panel has been checked by comparing its results with the results of all the other 8mm covered products in the EPD. The comparative analysis confirmed that the maximal variation is below the allowable limit for the GWP-fossil for A1-A3 and as a result, it can be considered as representative for all the 8mm products included in the EPD.

This EPD presents environmental impacts valid for  $1m^2$  with thickness 8mm of the product. The environmental impacts of the product with 12mm

thickness can be considered as proportional to the weight of the product. Accordingly, the environmental impacts for the 12mm can be obtained by multiplying the results by the conversion factor 1.5.

The panels are naturally hardened fibre cement panels comprising cellulose and polymer fibres for water retention, improved tensile load distribution and increased breaking load and distortion.

EQUITONE [natura] is a high-density fibre cement panel with a through coloured core, and a coloured semitransparent double layer acrylic finish which results in the structure (fibres) of the material shining through.


EQUITONE [natura] PRO is a high-density fibre cement panel with a through coloured core, and a coloured semi-transparent double layer acrylic finish which results in the structure (fibres) of the material shining through. The surface finish is matt with a UV hardened PU topcoat (front side), providing a hard, dirt resistant surface finish with a high abrasion resistance and a permanent and durable graffiti protection.

EQUITONE [textura] is a high-density fibre cement panel with a through coloured core, a coloured double layer acrylic finish, fillite filling and a hot-film sealing topcoat (front side) which provides a dirt resistant finish. The surface has a grainy structure. The rear receives a transparent back-sealing coating.

EQUITONE [pictura] is a high-density fibre cement panel with a through coloured core, and a coloured double layer acrylic coating. The surface finish is matt with a UV hardened PU topcoat (front side), providing a hard, dirt resistant surface finish with a high abrasion resistance and a permanent and durable graffiti protection.

#### **MANUFACTURING AND PACKAGING (A1-A3)**

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials for the final product and other ancillary materials (such as the various types of process water; other consumables used during production were neglectable). Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

Transport for raw materials considers the distance from the manufacturing location of the raw material to the production plant and the modelling of the relevant transportation type (e.g. bulk sea fret, road lorry, train, ...) for each raw material. Over 65% of our raw materials are sourced from suppliers within a radius of 150 km from our factories.

Regarding the energy used, natural gas, steam and electricity were consumed during manufacturing. The electricity used in the manufacturing plant is 100% sourced from the renewable sources (hydropower and solar panels).

#### **TRANSPORT AND INSTALLATION (A4-A5)**

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

For the transportation from the production plant to the building site, a scenario was assumed with a transportation distance of 100 km and using a lorry as transportation method.

For other transportation distances with lorry the impacts can be easily calculated by multiplying the impacts in module A4 with the lorry transport distance to the specific location and dividing by 100.

Installation (A5) of the product is according to the following scenario(s): fixation of the panel to a substructure. This EPD declares the screws and energy consumption to fixate the panels, but does not include the substructure as several substructures are possible. During the installation, depending on how the EQUITONE panels are cut, there is a loss rate between 5-30%. For this study, an average loss rate of 10% is used (scenario considered : landfill, transport 50km). All packaging material for the EQUITONE panels is transported to EoL (scenario: landfill 50km/recycling 100km) and waste treatment is included.

### **PRODUCT USE AND MAINTENANCE (B1-B7)**

The product has an estimated reference service life of 60 years, providing the product is installed as per Etex recommendations. In such case, the product will last during its life of use generally without any requirements for maintenance, repair, replacement, or refurbishment, providing normal and no accidental conditions of usage are encountered. The product will also not need any operational energy nor operational water to fulfil its duty, once installed in the building.

The only impact during the use phase is that of carbonation, where some CO2 is adsorbed from the atmosphere over the life time of the panel. Depending on the application where the panels are used, the degree of carbonation will vary. The carbonation was calculated for the outdoor use scenarios and reported in the B1 module.

Air, soil, and water impacts during the use phase have not been studied.

### **PRODUCT END OF LIFE (C1-C4, D)**

Two possible end-of-life scenarios are considered for the Equitone panels: Scenario 1: 100% landfilling scenario: 100% of panels from demolition wastes are going to landfill at end of life.


Scenario 2: 100% recycling scenario: 100% of panels from demolition wastes are going to recycling at end of life.

In both scenarios, the screws used for installation are considered to be 100% recycled.

For the dismantling of the Equitone panels in C1, the same amount of energy was assumed as for the installation.

The transport of the waste to the end-of-life (C2) is considered to be 50 km from the plant in the landfilling scenarios and 100 km from the plant in the recycling scenario.

Outside the system boundaries, module D shows benefits and loads from the recycling processes. In scenario 1 these are related to the recycling of the packaging materials and the screws. In scenario 2 these are related to the recycling of the fibre cement board, the packaging materials and the screws.








# **MANUFACTURING PROCESS**

### DESCRIPTION

The EQUITONE products are large format panels made of fibre cement. They are manufactured through the Hatschek process where the raw materials are first mixed together with water to form a slurry. For this we use a minimum of potable water in industrial processes. The slurry is then pumped into several vats with rotating cylindrical sieves on the surface of which a film of fibre cement is formed through a sieving mechanism as they rotate, which is then transferred to a felt belt traveling overhead. This thin layer of fibre cement is then dewatered before being transferred via the felt belt to a forming drum on which several layers of fibre cement are collected and squeezed together until the required thickness is achieved. Once this occurs, this fresh sheet of fibre cement is cut by an automatic cutting knife. A conveyor then transports the sheet to where all the sheets are stacked with an interleaving steel plate. The stacked sheets are then highly compressed, resulting in a high density material. This is followed by a curing process where the panels harden under ambient temperature and without vapour pressure. Subsequently the EQUITONE products are then dried and coated.

# LIFE-CYCLE ASSESSMENT

### **CUT-OFF CRITERIA**

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

### ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:

EQUITONE [natura], EQUITONE [natura] PRO, EQUITONE [textura] and EQUITONE [pictura] are produced in the same factory and are all throughcoloured fibre cement facade panel. This EPD refers to all declared materials produced with grey cement. All products covered in this EPD have similar recipe, differences are limited to the pigmentation and finishing coatings received.

The results declared in this EPD are for EQUITONE [natura] 8 mm using the anthracite baseboard, which was chosen as representative product for the group as it represents the highest volume of the grouped products. LCA calculations were performed for each of the covered products and the results were compared to the results for the representative product. The variation analysis confirmed that the maximal variation was below the allowable limit for the GWP-fossil for A1-A3.

The products also exist in a 12 mm variant for which the environmental impacts can be considered as proportional to the weight of the product. Accordingly, the environmental impacts for the 12 mm can be easily obtained by multiplying the results in this EPD by the conversion factor 1.5.

#### LCA SOFTWARE AND BIBLIOGRAPHY

This EPD has been created using One Click LCA EPD Generator. The LCA and EPD have been prepared according to the reference standards and ISO 14040/14044. The EPD Generator uses Ecoinvent v3.8, Plastics Europe, Federal LCA Commons and One Click LCA databases as sources of environmental data.




# **ENVIRONMENTAL IMPACT DATA**






